

PROCEDUI

- 1. In a small beaker, melt ingredient 2.
- 2. In the main vessel, premix ingredient 1 & 3, once surfactant is fully in solution, add in remaining ingredients in phase 1.
- 3. Phase 2, premix ingredients.
- 4. Add phase 2 into 1, mix until homogeneous.
- 5. Add in Phase 3.
- 6. Once cooled, adjust pH to 5.5-6.5 with ingredient # 11.
