

GENERAL TERMS AND CONDITIONS FOR RETURNABLE TRANSPORT PACKAGING of Univar Solutions Belgium N.V., for Belgium, The Netherlands and Luxembourg

The use and hire of returnable transport packaging is subject to the following conditions:

1. DEPOSITS, MAINTENANCE AND RENTAL FEES

The deposits and maintenance costs will be taken into account when invoicing the packaged and delivered products. Packaging deposits are not subject to VAT, but the maintenance cost is subject to VAT at the current rate.

2. DETENTION OF PACKAGES

Returnable transport packaging remains the property of the vendor. It must be returned to the vendor within 2 months of the free delivery date, in a good condition both internally and externally, hermetically sealed, clean and not soiled, and having not contained products other than those which have been invoiced. They must be completely empty and not contain any remnants or residues, with a minimum charge of €60 per package applied, should this not be the case. In this case, the vendor reserves the right to refuse the return and not to credit the deposit for the returnable transport packaging.

3. COLLECTION OF PACKAGING BY THE SUPPLIER

The pick-up is made free of charge, on condition that there was an equivalent delivery and that the packaging is grouped in the unloading area.

In all other cases, the fees charged are borne by the client with a minimum charge of €115.

The restitution of packaging will have to be done according to the rules of stowing in force. In the contrary case the vendor reserves the right to refuse the recovery and to invoice expenses being able to result from it.

4. NON-COMPLIANT PACKAGING COLLECTED OR RETURNED

- Packaging with holes, that is dirty, rusty, ruined or damaged: will be decommissioned and the deposit will not be credited.
- Containers and drums containing remnants or residues: not accepted for pick-up. If, however, they are collected in error, the deposit is not credited and the disposal costs are invoiced.
- Containers & Drums: Missing plug or bung: €3.50
- Multi-box: Deterioration of valves, joints, covers, metal reinforcements, polyethylene tanks, etc...: the costs of repair are borne by the client.

5. RENT

Fixed fee, of 49,00 €, for every IBC, upfront payable upon delivery of the goods.
