Plus, we will be able to offer you more digital features, such as 24/7 access to our full product catalog, online ordering, order and shipment tracking and document access, and much more. We are approaching the final Go Live of our USA SAP Integration for our chemicals business in our East Region and we are also preparing to migrate the legacy Univar Chemcare waste and services activities in 2021. We are prepared to transition your company on **Monday, February 15, 2021** as part of the East Region which will complete our SAP integration in the USA. Please Review These Important Dates and Action Items

1. Key Dates:

- **Please plan ahead for orders the week of February 8:**
To help ensure there is no disruption to your service, we ask that all orders being placed during the week of February 8 are submitted to your Customer Solutions Representative as early in the week as possible, but no later than noon Thursday, February 11. Should you have an emergency delivery request, please contact your Customer Solutions Representative or Sales Account Manager for assistance.
- **Friday, February 12, 2021:**
We will have the ability to deliver and prefer to reserve that for customer emergency orders

(any new orders will be processed February 15). Please coordinate your order delivery early in the week of February 8 to ensure no service disruption.

- **Monday, February 15, 2021:**
SAP will be live, and we will return to normal business operations.
- 2. **Set-up new remit-to banking information:** *Use the new remit-to banking information for the Univar Solutions USA Inc. vendor account, which is provided in the chart below. Please work with your CSR to verify and update.*
- 3. **Purchase Orders:** *As of February 15, all purchase orders should be issued in the name of Univar Solutions USA Inc. Tax exempt customers must provide an updated tax exempt certificate under this legal name no later than February 15.*
- 4. **Deliveries:** *To ensure the best transition possible and avoid supply interruption, we will be contacting you to deliver as many items as possible prior to the system conversion on February 15. If you have any questions relating to deliveries for the weeks of February 1 and 8, please reach out to your Customer Solutions Representative.*
- 5. **Use Univar Solutions USA Inc. vendor account for all transactions on Feb 15 or after:** *On February 15, inactivate any vendor accounts associated with the legacy companies, Legacy Nexeo or Legacy Univar USA Inc. If you still encounter documents and labels with the legacy company branding and names, these are still legally valid and can be accepted as usual. After the effective date of the system change, you will start to receive sales confirmations, proofs of delivery, bills of lading, invoices and other documents with the Univar Solutions logo.*

We appreciate your business and thank you for your patience as we work hard to make the transition to a new system as seamless as possible. Our primary focus through these changes continues to be you – your needs and our ability to provide exceptional service, especially in these unprecedented times. - **Legal Entity / Vendor Account**

Beginning February 15, 2021, we will have completed the SAP integration for the chemical business in the USA and will be transacting as **Univar Solutions USA Inc.** for USA sites.

Communications from our systems will have the logo and name of Univar Solutions USA Inc. These communications include order confirmations, proofs of delivery, bills of lading, and invoices.

After February 15, 2021, please inactivate vendor accounts associated with the legacy companies Nexeo Solutions or Univar USA Inc.

- **Bank Accounts**

Payments made for Legacy Univar purchases on or after February 15, 2021 for all USA sites should now reflect the Univar Solutions USA Inc. remit-to information. These changes will also be reflected on our invoices. **We ask you to confirm all requests for bank account changes with your known Customer Solution Representative to avoid instances of fraud. Univar Solutions cannot be held accountable for payments made to a fraudulent account.**

- **New Sales Tax Exemption Certificate Needed**

A new sales tax exemption certificate needs to be on file in the name of Univar Solutions USA Inc. to facilitate exempt sales. Requests have been sent out to facilitate this and completed certificates should be returned to taxcert@univarsolutions.com. It is very important these certificates be on file prior to February 15 to prevent delays in shipments or errors in billing. Your Customer Solutions Representative or Sales Account Manager can provide assistance.

- **Product Codes / Descriptions**

You will see new product codes and descriptions as a result of the system transition. Specifically, the product descriptions have been modified to include the container type.

- **Lot Numbers**

Effective February 15, 2021, products packaged within Univar Solutions facilities will be assigned a sequential lot numbering scheme generated from SAP using 10 numeric characters, which represents a change from our current 10 character alpha numeric lot numbers. Read more [here](#).

- **Legal Consent Form**

A legal consent may be required to transfer an active legal agreement from one legal entity to another. If you have a contract in place that requires attention, we will have sent you a legal consent form by mail to sign and return. The name change does not affect your contract. and does not require an assignment or an amendment.
