We are pleased to announce that on September 1, 2019, we successfully moved the assets of Nexeo Solutions LLC into Univar USA Inc., changed our name and are now known as Univar Solutions USA Inc. (Univar Solutions). Coming together under one legal entity is a key step in fulfilling our vision to redefine distribution and be the most valued chemical and ingredient distributor on the planet.

In addition to our legal entity change, we are planning the integration of our legacy Univar business systems into legacy Nexeo business systems in geographic waves, moving west to east, through the end of 2020. Our Pacific Northwest region, which includes ship-to locations in Washington, Oregon, Alaska, and Idaho, is the first wave affected by our systems migration. We have identified your company as having a ship-to location in this region. Please read on for some additional notices.

Starting on October 14, 2019, we will support the ship-to locations in the Pacific Northwest from our integrated Univar Solutions SAP system. With this system transition, we ask you to begin using the new Univar Solutions USA Inc. vendor account you set up based on our July 2, 2019, request. We have included the vendor account set up information at the end of this communication for your convenience. Please note that there is new remit to banking information for this vendor account, which is also provided within this communication. We welcome you to confirm these bank changes with your current Customer Service Representative or Sales Account Manager.

If you purchase products from Univar across the United States, it is important that you keep both the Univar Solutions USA Inc. and Univar USA Inc. vendor accounts active in your business system with the different remit to addresses for payment. Until we have migrated all our systems onto a single platform, we will continue to execute purchase and sales transactions from two systems and this separation will enable us to maintain exceptional service. During the transition period, you may still encounter documents and labels with the legacy company branding and names. These are still legally valid and can be accepted as usual. After the effective date of the system change, you will start to receive sales confirmations, proofs of delivery, bills of lading, invoices and other documents with the new Univar Solutions logo.

We appreciate your business and thank you for your patience as we work hard to make the transition to a new system and become a fully integrated Univar Solutions as seamless as possible. Our primary focus through these changes continues to be you – your needs and our ability to provide exceptional service and make it easy to do business together.
