Effective September 1, 2019, we will move the assets of Nexeo Solutions LLC into Univar USA Inc., and the name of the combined entity will reflect our new name, Univar Solutions USA Inc. (Univar Solutions). Coming together under one legal entity and one operating platform are key steps in fulfilling our vision to redefine distribution and be the most valued chemical and ingredient distributor on the planet.

As a supplier that has done business with Nexeo Solutions Inc. there are several key steps that we would like you to take to ensure that our companies can continue to transact in an efficient manner.
