## Procedure (Warm process)

- Weigh phase A and add it to main vessel
- 2. In a separate vessel, blend phase B until uniform
- When completely clear, slowly add pre-mixed phase B to phase A and mix until uniform
- Add phase C in order to the batch, mixing to ensure uniformity between additions
- 5. Warm phase D at 40°C and add to the batch
- 6. Add phase E and mix until uniform

## Stability

Stable at least 1 month at room temperature, 4°C and 40°C (still ongoing).

## Comments

- Application: Drop off some oil into the palm of your hand and work the texture with your fingertips. Apply throughout paying special attention to hair tips to bring them conditioning benefits.
- Slightly yellow textured clear oil
