- Combine and heat ingredients of phase B to 75-80°C until completely melted and homogeneous Once both phases reach 75-80°C, add phase B to phase A under agitation (Silverson/Ultra Turrax for 15min at 4,000-4,500 rpm)
- 4 Cool down phase AB to 45°C under agitation
- Add phase C ingredients to phase AB in the order listed and mix between each addition
- Add phase D ingredients to phase ABC under agitation
- Below 40°C, add phase E ingredients to phase ABCD in the order listed and mix between each addition

#### 8 Adjust the pH between 5.0 and 5.5 with phase F

Stable 3 months at 4°C, RT and 40°C.

- Viscosity (spindle 6; 10 rpm; 1min) = 29,800 cPs (29.8%)
- Application: Apply to damp skin on the face and neck once to twice a week. Massage lightly using circular motions. Rinse-off with lukewarm water.
