Procedure (Hot Process)

- 1. Combine phase A ingredients and heat to 85°C (closed vessel).
- Disperse B into A with a Silverson equipment at 2000 rpm (85°C-closed vessel).
- Maintain heat at 85°C while mixing at 4000RPM (Silverson) for 10min (closed vessel).
- When it is clear and homogeneous, cool down to room temperature and add phase C with gentle stirring.

Stable at least 2 months at room temperature and 40°C (still ongoing).
