PROCEDURE

1. Charge water and begin mixing. Add lecithin with mixing to start hydration.
2. Add remainder phase A ingredients with mixing.
3. Combine phase B ingredients in separate vessel. Mix to dissolve phytantriol.
4. Once lecithin is fully hydrated (30-60 minutes), add phase B to phase A with mixing.
5. Combine powders of phase C and mix to disperse xanthan gum and sodium hyaluronate.
6. Add phase C to AB with mixing, increasing mixing speed as needed.
7. Add phase D to ABC with mixing. Continuing mixing to fully hydrate and dissolve all ingredients.
