

## Zero-landfill program for luxury car maker.

The manufacturer was able to integrate efficiencies across its waste accumulation and handling processes, driving the car maker to zero-landfill status. The program improved the plant's annual waste diversion rates to 65% recycling, 20% reuse and 15% waste-to-energy programs—all while garnering more than \$1.35 million in total recycling rebates.
