Energy Intensity



- Infrastructure investments:
 - Installation of high efficiency lighting at a number of locations
 - Installation of solar array, and upgrading to external insulation, supported by thermal water heating at Morolo site, Italy
- Improved processes and procedures including through our sustainability assessment program, identifying opportunities including optimizing heat system, proactive leak detection and integrating energy considerations into closedown processes
- Rewarding sustainability leaders: In 2020 we launched the Phil Hockaday Sustainability Award, in honor of VP of Global EHS. This award is presented annually to the person who has brought forward the best sustainability programs and ideas

- Advancing a circular economy across our supply chain by collaborating with industry partners to exemplify circular principles, diverting thousands of tonnes of isopropyl alcohol, spent sulfuric acid, and propylene glycol from entering waste streams.
- Maximizing recycling including through our ChemCare business which handled over 200,000 tons of customer waste, diverting over 55% from landfill by using it for energy, heat generation, recycling and beneficial reuse
